- When paying for NACIA and NASPA dues please make check payable to the specific association. Any check made payable to NCSA for these dues will be returned.

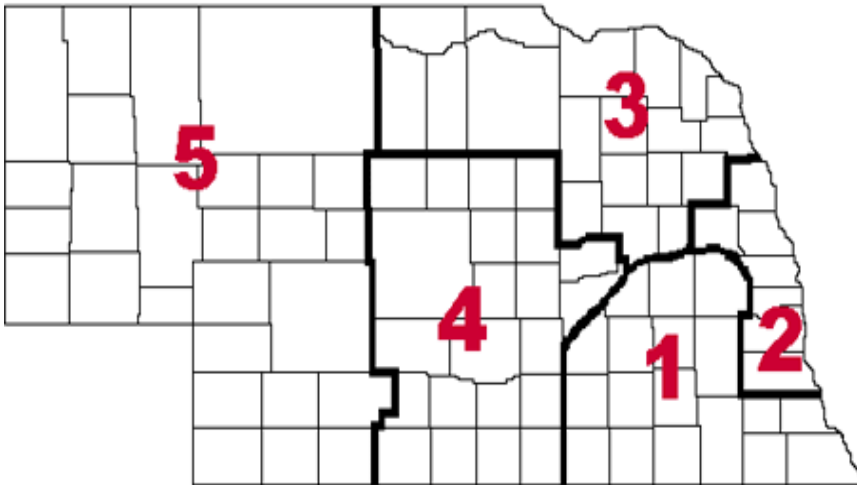
## 6. AASA Membership
