ACCESS Meets AQuESST – Stateroom A & B

Find out how you can maximize 20 minutes each day at your school to engage your students and address AQuESTT tenets! Paxton Consolidated Schools developed ACCESS (Achieve, Commit, Complete, Excel, Study, Succeed) a 20-minute daily study period in which all 6-12 grade students are divided into cross-age (GR 6-8, GR 9-12) groups. ACCESS is designed to develop supportive, caring relationships with each team of students to promote positive attitudes about learning, homework completion, and goal setting. ACCESS time is also devoted to reaching our AQUESTT college and career readiness goal. Students complete Nebraska Career Connections surveys and career cluster exploration. Students also create and share a Genius Hour Project ending with a product that is matched to their unique interests and talents. At the end of each quarter students and staff do ACCESS group activities that are tied to the school improvement goal to improve math skills K-12. Such activities have included Minute to Win It math games, Human Sudoku, Metric Olympics and tower building. Paxton school administrators and teachers will share their story and describe the ACCESS evolution to meet AQUESTT tenets and more!

Lockdown: This is Not a Drill! – Stateroom C

On April 26th, 2018 Nebraska City Schools experienced a multiple threat event which forced all of the Nebraska City Public Schools, the Parochial School and NCECBVI (Nebraska Center for the Education of Children who are Blind or Visually Impaired) into a Lockdown. The threat resulted in the Nebraska City High School students and staff remaining in lockdown for several hours with law enforcement tactical teams escorting the individual classes out of the building, at gun point, to a reunification point. You can practice lockdowns and discuss your Emergency Response plans, but can never fully understand the dynamics of working with law enforcement, community, media and parents until you experience an actual event. The session will be a panel discussion with some of the Nebraska City Schools Administrative Team who will share their experiences, what was learned, what changes need to be made, and answer questions you may have.

2019 Legislation Updates for Pupil Transportation – Stateroom D

We have had school-wide challenges and competitions, mental toughness activities, lessons from the Angela Duckworth book: Grit, lessons from the strategies of E+R=O framework, and lessons on developing a growth mindset rather than a fixed mindset (ideas from Carol Dweck).

"It's More Than You Can See From the Street" This process was comprehensive and the results were used to inform the Board of Education efforts with long-range planning.

Discriminatory Chants/Signs at Games – Loper North

Attendees will leave this session with tools and roadmap to develop a CTE process that unites small rural schools, business partners, and post-secondary education that provides innovative programming to students. The presenters will review the Nebraska reVISION process that is changing the face of CTE in Northeast Nebraska.

Human Trafficking – Diamond 1
